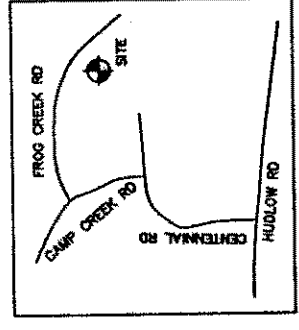

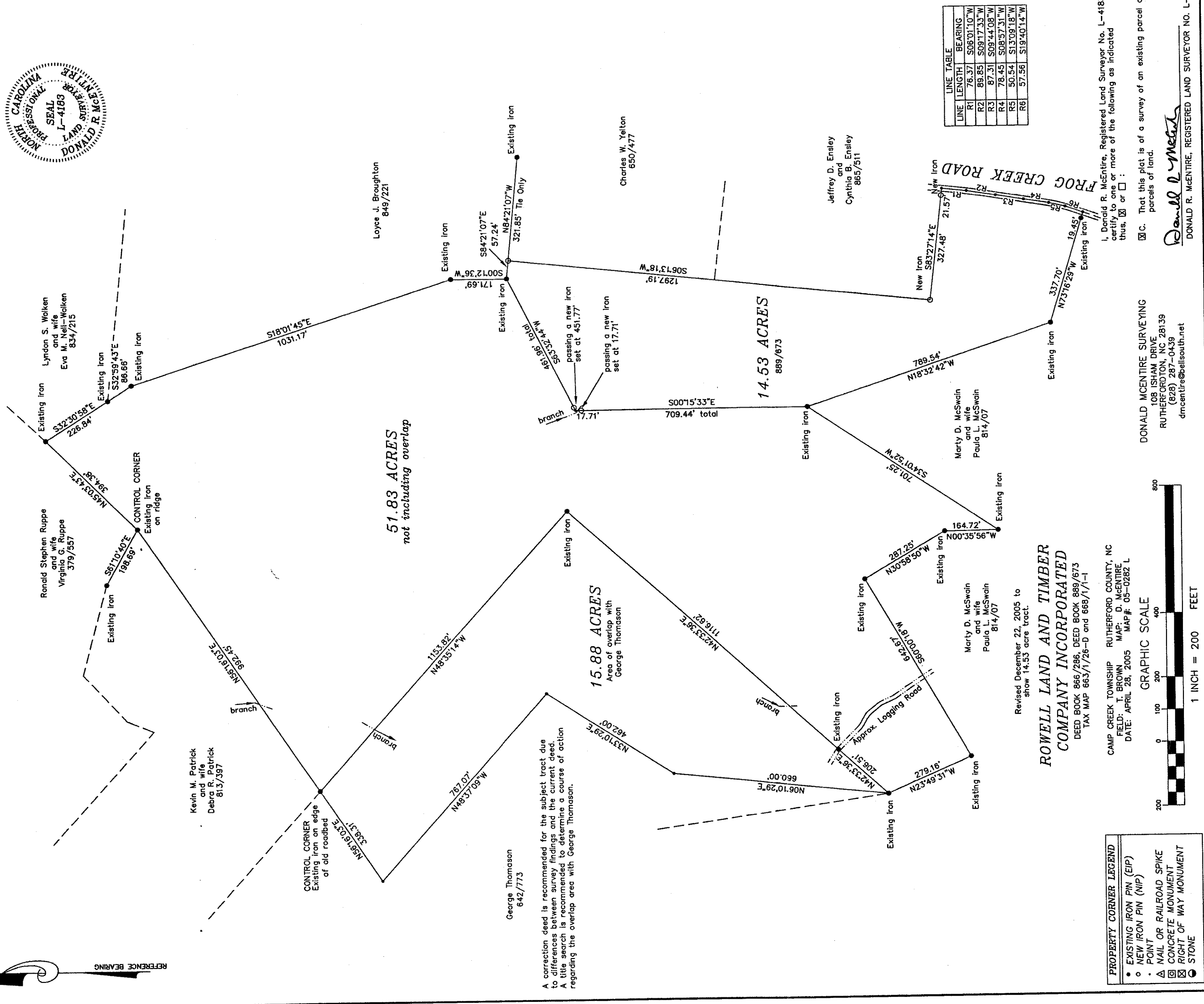
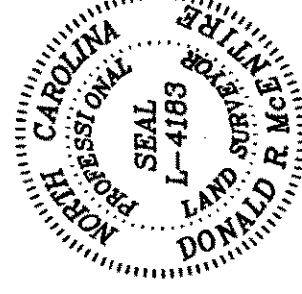
VICINITY MAP

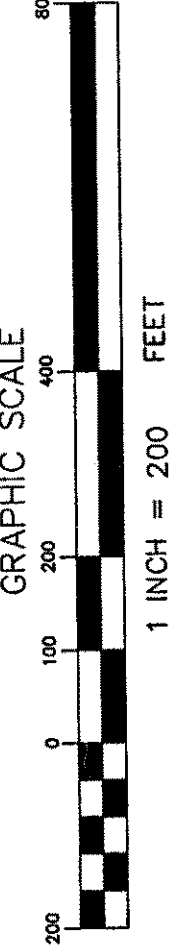
